Subject: Cyber Security Advisory – Primary & Secondary Health Department – Government of Punjab (Advisory No. 07)

It has been revealed that Primary and Secondary Health Department, Government of Punjab's (PShealth) website (www.pshealthpunjab.gov.pk) is exposing personally identifiable information (PII) of employees including name, address and CNIC number on their publicly accessible website under orders and notifications webpage.

2. It is suggested that complete CNICs should not be uploaded on the website, as it may reveal complete details of a person and become lucrative for the terrorists/criminals. In case, CNIC is necessary to be uploaded in the appointment letters, it may be skimmed/partially hidden; for example, 42110-xxxxxx-8. Health Information Service Delivery Unit (HISDU) and Punjab Government P&S Health Department may be sensitized accordingly.

3. Kindly disseminate the above information to all concerned in your organizations, all attached/affiliated departments and ensure necessary protective measures.
