GENERAL CONDITIONS

- 1. The candidates are advised to apply on-line by visiting the website i.e. <u>www.mnsuam.edu.pk</u> after reading all terms and conditions (Applications other than On-line shall not be accepted by the University).
- 2. The onus/responsibility of correctness of the data given in the on-line application will responsibility of the candidate.
- 3. Last date to apply **ONLINE** is **24.09.2025** and to submit the applications in **hard form till 26.09.2025** four sets (dossier) for above mentioned position with attested copies of all certificates, degrees, testimonials, detailed marks certificates, experience certificates with specific dates, publications, transcripts, equivalence certificates, CNIC, domicile.
- 4. Original Bank Draft of the fee amounting to Rs. 1500/-, in favour of Treasurer, Muhammad Nawaz Shareef University of Agriculture, Multan for each position must be attached with hard copy of application dossier.
- 5. The foreign qualified candidates must attach equivalence certificates of foreign degree from Higher Education Commission of Pakistan.
- 6. 3% quota is reserved for disabled persons, 5% quota for Minorities (Non-Muslims) and 15% quota for women. Transgender can apply, if eligible for the post applied for.
- 7. Candidates already in service should apply through proper channel/NOC issued by the authority **by due date**. The Annual Confidential Reports (ACRs) grading for the last five years may also be recorded in the forwarding letter.
- 8. Applications will be short-listed according to the University prescribed criteria.
- 9. Applicants have no right to claim for regularization their services in any court of law.
- 10. The University has right to increase or decrease the posts.
- 11. The University reserves the right not to fill any post or withhold appointment against any post without assigning any reason.

- 12. Candidates terminated/dismissed under any disciplinary law from the service by any of the Government / Semi-Government / Autonomous bodies are not eligible to apply.
